Thank you for your ongoing support of the Nashville Baptist Association. We are pleased to report on some of the ways your investment has resulted in churches helping churches.

#### **Connections in Pastor Fellowship Groups**

The ministry of the Nashville Baptist Association is based on trust and relationships, and it is therefore vital for cooperative ministry efforts in the future for church leaders to make intentional efforts to grow in relationship with each other. The association now has several local groups of pastors regularly meeting together to pray, encourage one another, and help each other problem solve:

#### **Connections Through Ministry Networks**

There are a variety of ministry networks operating within the Nashville Baptist Association. We continue to support the facilitation of these networks for the purpose of kingdom expansion in Nashville and Middle Tennessee. Current networks include men's ministry, preschool, children, senior adults, women's ministry, youth ministry, and more. #### Leadership Development Through Peer Learning

The association provides monthly environments for leadership development through our series of peer learning webinars. These webinars, led by pastors and church leaders from the association, are meant to be relevant, practical and aimed at specific areas of ministry. #### **Church Revitalization**

One of the key areas for focus must be church revitalization. The association engages this often difficult and time-consuming issue through partnerships - helping churches to revitalize other churches. There are currently several churches at various stages in partnerships like these including:

#### **Church Planting**

The Nashville Baptist Association helps churches plant other churches. In order to help churches adopt a church-planting mindset, we will begin the Churches Planting Churches Cohort in 2024. The cohort will be a small group of church leaders from several churches who commit to a year of monthly meetings.

Each meeting will consist of a combination of content, prepared and presented by a local church leader, and exercises to be completed during the month with their own church and leadership team. The goal would be that after a year, more churches find themselves in a posture ready to plant or help plant additional churches in the future.

#### **International Ministry**

The Nashville Baptist Association has over thirty churches that worship in a language other than English. These churches work among a Nashville population that is over 10% Hispanic, 4% Asian, and the largest Kurdish population in the United States. We have worked this past year to create meaningful partnerships between international and domestic congregations.

In the coming year, we will work to create more of these partnerships. As with all other partnerships, we desire to help churches help churches, and as with any partnership, the benefits should flow in both directions. We will seek to facilitate new relationships between international and domestic congregations that are mutually beneficial in nature.

### Churches Leaving the NBA

Membership in the Nashville Baptist Association is voluntary in nature. ### **2** NBA Bylaws Amendment

The Board of Directors recommends the following change to the bylaws of the Nashville Baptist Association:

 $\mathbf{06}$ 

#### Article 8: Dissolution

In the event of the dissolution of the Nashville Baptist Association Inc., any assets of the corporation then remaining shall be conveyed to the Tennessee Baptist Mission Board that is exempt under the meaning of section 501(c) (3) of the Internal Revenue Code of 1954 as amended or under successor provisions of the Code as may be in effect at the time of dissolution.

The Directors, by a three fourths (3/4) vote, may bring a Motion to the Messengers at any Annual meeting, to dissolve and terminate the Nashville Baptist Association Inc. Upon a three fourths (3/4) vote of the Messengers present at the Annual Meeting, the Messengers may approve the Motion, thereby authorizing the Directors to take all necessary actions to dissolve and termination the Corporation.


